As per the government notification No. DE.151 ರಾಜಪ, Date: 25.11.2019, Sri Panchalingaswamy S. Assistant Controller of State Accounts had been appointed as Finance Officer for Karnataka Samskrit University, on additional charge and as per the government notification DE 151 ರಾಜಪ, dated: 02.08.2021 he has been promoted and transferred to Devaraju Arasu Backward Community Development Corporation, Bangalore from Kidwai Hospital, Bangalore. Sri Panchalingaswamy S handed over the charge of Finance Officer to Registrar on 02.08.2021.

To handle these cases, University has appointed Sri. Venkatesha C. High Court Advocate and his monthly honorarium is fixed for Rs. 15000/-. The payment of the advocate is pending for 17 months. So, this has to be paid. Hence, the subject is placed before the syndicate for permission to pay the pending payments.</p>

16	Sending Proposal to Government for Grant in aid As per the government letter No: 24 UNE 2021 Dated: 10.11.2021, 03.05.2021 and 20.05.2021, government has directed to include below listed 5 Pathashala for Grant in Aid. Based on this letter, University had constituted three-man committee for these Pathashalas. The committee members have visited the pathashalas and submitted the reports with recommendations. Sri Guru Brahmananda Samskrit Pathashala, Bhairanahatti, Naragunda Taluk, Gadag Dist. 3. Sri Vairagya Mallannarya Samskrit Pathashala, Kenduru, Badami Taluku, Bagalakote Dist. 4. Sri Guru Puttaraja Samskrit Veda Pathashala, Kalladevanahalli Post, Hunasagi Taluk, Yadagjri Dist. 5. Gurugunta Sri Amareshwara Samskrita Veda Pathashala, Amareshwara, Devarabhupura, Lingasugur Taluk, Raichur Dist. The subject is placed before the Syndicate for permission to send these proposals to government for grant in aid.

17	Considering the CAS benefit of Prof. Veerannarayana N.K. Pandurangi. Prof. Veerannarayana N.K. Pandurangi was appointed as Associate Profeseor in Karnataka Samskrit University on 05.03.2014 and got CAS promotion on 05.03.2017. Prof. Veerannarayana N.K. Pandurangi has requested to consider his CAS promotion from 05.03.2011, because he was working as Associate Professor previously in JRRSU from 2005. The same subject was placed in the previous meeting and the subject was deferred. Hence, the subject is placed before the syndicate for final decision.
Decision	The syndicate had a tread bare discussion on the feasibility of considering Prof. Veerannarayana N.K. Pandurangi's request to give CAS promotion from 05.03.2011. Some Hon'ble members suggested to give the CAS promotion from the date of joining as Associate Professor in this university. However other Hon'ble members suggested to send a letter to the Govt of Karnataka for their guidance. Hence it is decided to send a letter to DPAR, GOK as per the opinion of the majority of the members.
