Fixed Pay for Guest Faculty:

1. 32000/-Per month for the candidates who have Phd degree/NET/SLET/SET along with Masters degree and have 05 years of teaching experience

2. 30000/- Per Month for the candidates who have Phd degree/NET/SLET/SET along with Masters degree (below 5 years of experience)

3. 28000/- Per month for the candidates who do not have Phd degree/NET/SLET/SET SET along with Masters degree but have 05 years of teaching experience

4. 26000/- Per month for the candidates who do not have Phd degree/NET/SLET/SET (below 5 years of teaching experience)

PS: No other allowances payable to the candidate

Qualification required for the Post of Guest Faculty as per the UGC Guidelines and University C&R rule.

1.GUEST LECTURE YOGA-01 POST(FULL TIME)

- 1) Holders of Ph.D. degree as on the date of Notification of UGC Regulations, along with those candidates who are awarded a Ph.D. degree through a process of admission, registration, course work and external evaluation as laid down in the UGC (Minimum Standards and procedures for award of M.phil/Ph.D. Regulations, 2009 and so adopted by the university, shall be exempted from NET/SLET/SET.
- 2) Besides fulfilling the above qualification, the candidate should have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar tests accredited by the UGC like SLET/SET preferred.
- 3) Good academic record as defined by the concerned University with at least 55% of the marks (50% marks in case of candidates belonging to SC/ST) or equivalent grade wherever grading system is practiced at the Master's degree level (M.SC/MA in YOGA/ SAMSKRIT with PG-DIPLOMA in YOGA) in a relevant subject from an Indian University or an equivalent degree from an accredited foreign University.
- 4) Distinguished and eminent having acquired high repute for propagation and disseminating the Sanskrit knowledge.

2.YOGA THEARAPY and COUNSELLING-01 POST (FULL TIME)

- 1) Holders of Ph.D. degree as on the date of Notification of UGC Regulations, along with those candidates who are awarded a Ph.D. degree through a process of admission, registration, course work and external evaluation as laid down in the UGC (Minimum Standards and procedures for award of M.phil/Ph.D. Regulations, 2009 and so adopted by the university, shall be exempted from NET/SLET/SET.
- 2) Besides fulfilling the above qualification, the candidate should have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar tests accredited by the UGC like SLET/SET.
- 3) Good academic record as defined by the concerned University with at least 55% of the marks (50% marks in case of candidates belonging to SC/ST) or equivalent grade wherever grading system is practiced at the Master's degree level (BAMS /BNYS with MD in Yoga/Panchakarma and PG-DIPLOMA in YOGA) in a relevant subject from an Indian University or an equivalent degree from an accredited foreign University.
- 4) Distinguished and eminent having acquired high repute for propagation and disseminating the Sanskrit knowledge.

Notes:

1. Qualification and other eligibility conditions are as per UGC Regulations 2016 published in the Official Gazette of India dated 4th May, 2016 and the Statutes governing the Cadre and Recruitment of the Employees of Karnataka Samskrit University.

2. Reservation norms are followed as per the orders issued by the Government of Karnataka from time to time.

3. API Score will be awarded only on production of relevant documentary evidence in support of claims made duly signed by the competent authority.

4. University reserves the right to fill or not to fill any of the vacancies notified.

5. The University has right to shift any post from one faculty to another as per requirement.

6. Incomplete and Late Applications will not be considered.
