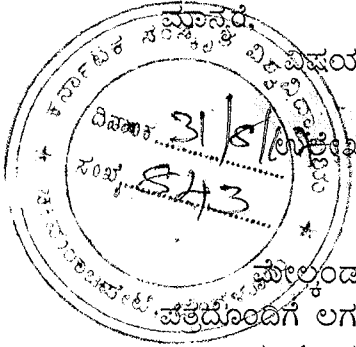



**PREAMBLE:**

The University Grants Commission has issued Notification No. F.No. 1-1/2012(CPP-II), dated 11.07.2016 published in the Gazette of India (Extra Ordinary) relating to University Grants Commission (Promotion and Maintenance of Standards of Academic Collaboration between Indian and Foreign Educational Institutions) Regulations -2016 after repealing the earlier Regulations of 2012.

These Regulations will be applicable to:

- (a) All the Foreign Educational Institutions operating in India through Collaboration with Indian Educational Institutions, other than Technical Institutions, prior to the coming into force of these Regulations or intending to operate through Collaboration, for offering their programmes leading to award of Degree.
- (b) Indian Educational Institutions, other than Technical Institutions, already collaborating prior to the coming into force of these Regulations, are intending to Collaborate with Foreign Educational Institutions for offering programmes of study leading to award of Degrees.
- (c) Any Indian Educational Institutions or Foreign Educational Institution already having a Collaborative arrangement shall comply with these Regulations within a period of 6 months from the date of their coming into force.
- (d) These Regulations shall come into force on the date of their publication in the Official Gazette.



Byrappa, Vice-Chancellor, Mangalore University, warmly welcomed the committee members and briefed the committee about the deliberations of the previous meeting held on 14-12-2016 pertaining to framing of Draft Common Regulations Governing Minimum Standards and Procedure for award of M.Phil/Ph.D Degrees-2016.

Reiterating the fact that the basic structure of *University Grants Commission (Minimum Standards and Procedure for Award of M.PHIL./PH.D Degrees) Regulations, 2016* should be upheld, the Chairperson stressed for comprehensive study and bringing in only relevant and necessary additions to the regulations.


With insightful observations and suggestions by Prof. D. Shivalingaiah, Vice-Chancellor, KSOU, Mysore, Prof. Shubash M.S., Vice-Chancellor, VSKU, Bellary and Prof. Lingaraj Gandhi, Director- PME B, University of Mysore, Mysore, the committee deliberated in detail on all the clauses in the Regulations and concluded on a few necessary matters to enhance the quality and excellence in research pertaining to the award of M.Phil and Ph.D degrees.

In continuation of the previous meeting the committee discussed at depth varied provisions with regard to clarity in terminologies related to degrees, recognition of research centers and their jurisdictions, the criteria for M.Phil/Ph.D entrance exams, duration of M.Phil/ Ph.D degrees, guideship, examiners panel, bringing in certain terminology on par with the extant one, for instance bringing in 'Doctoral Committee' in place of Research Advisory Committee etc.

The Chairperson once again stressed the need to bring in all doctoral theses which are being submitted in local/regional languages under the ambit of plagiarism check and requested the Karnataka State Higher Education Council to facilitate a procedure for the same.

The Committee concluded the meeting unanimously on the said subject matter and has recommended the proposed draft guidelines for Minimum Standards and Procedure for Award of M.PHIL./PH.D Degrees) Regulations, 2016 which is enclosed at Annexure -I.

The meeting ended with thanks to the Chair and the members.

ANNEXURE-I

**Draft Common Regulations Governing Minimum Standards and Procedure for award of M.Phil/ Ph.D Degrees-2016**

(University Grants Commission -Minimum Standards and Procedure for Award of M.PHIL./PH.D Degrees Regulations, 2016)

**1. Short title, Application and Commencement:**

- 1.1 These Regulations may be called University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016.
- 1.2 They shall apply to every University established or incorporated by or under a Central Act, a Provincial Act, or a State Act, every affiliated college/institutes recognized as research centers by the concerned Universities/ Private Universities, and every Institution Deemed to be a University under Section 3 of UGC Act, 1956.
- 1.3 These Regulations shall come into effect from the date of assent of the Chancellor.

**2. Eligibility criteria for admission to the M.Phil. programme:**

- 2.1 Candidates for admission to the M.Phil. programme shall have a Master's degree or a professional degree in relevant/allied/concerned subjects declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.
- 2.2 A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/Cat.-I/Differently-Abled and other categories of candidates as per the decision of the Commission from time to time, or for those who had obtained their Master's degree prior to 19<sup>th</sup> September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

**3. Eligibility criteria for admission to Ph.D. programme:**

Subject to the conditions stipulated in these Regulations, the following persons are eligible to seek admission to the Ph.D. programme:

- 3.1 Master's Degree holders satisfying the criteria stipulated under Clause 2 above.
- 3.2 Candidates who have cleared the M.Phil. course work with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) and successfully completing the M.Phil. Degree shall be eligible to proceed to do research work leading to the Ph. D. Degree in the same Institution in an integrated programme. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade,

may be allowed for those belonging to SC /ST/ Cat.-I Differently-abled and other categories of candidates as per the decision of the Commission from time to time.

- 3.3 A person whose M.Phil. dissertation has been evaluated and the viva voce is pending may be admitted provisionally to the Ph.D. programme.
- 3.4 Candidates possessing a Degree considered equivalent to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions subject to equivalence established by the host University shall be eligible for admission to Ph.D. programme.

4. Duration of the Programme:

4.1 M.Phil. programme shall be for a minimum duration of two (2) consecutive semesters / one year and a maximum of four (4) consecutive semesters / two years.

Imp

4.2 Full time Ph.D. programme shall be for a minimum duration of three years, including course work and a maximum of five years. A candidate who has registered on full time basis shall carry out the research for a minimum period of three years from the date of enrolment. The candidate registered on part time basis shall work for a minimum period of four years from the date of enrolment. However, a part time candidate may be permitted to work on full time basis on valid grounds. In such a case, the period of registration shall be three years from the date of change over or four years from the date of enrolment, whichever is early. A full time candidate may also be permitted to work on part time basis, but the period of such registration shall be four years from the date of original enrolment.

If the candidate is working in a research project sponsored by a national agency on a full time basis for three or more years with sufficient research progress and standard publications, but not registered for Ph.D., earlier due to some reasons, if found fit to submit the thesis, can be allowed to submit the thesis after TWO years from the date of enrollment after fulfilling the prescribed Ph.D. course work and colloquia.

Imp

A full time candidate shall complete the research work and submit the thesis to the University within a maximum period of five years from the date of enrolment while in the case of part time candidates the maximum period for submission shall be six years.

Imp

4.3 Extension beyond the above limits shall be for a period of one year. In exceptional cases extension of time beyond the maximum permissible period may be allowed on sufficient justification and on the recommendation of the guide along with payment of the prescribed fee.

Alles 3+2

4.4 If a candidate fails to submit the thesis even after extension, he/she shall re-register and submit it within two years, failing which he/she has to register afresh.

5+2 Re-registration

4.5 The women candidates and Persons with Disability (more than 40% disability) may be allowed a relaxation of one year for M.Phil. and two years for Ph.D. in the maximum duration. In addition, the women candidates may be provided Maternity Leave/ Child Care Leave once in the entire duration of M.Phil./Ph.D. for up to 240 days.

5. Procedure for admission:

- 5.1 All Universities and Institutions Deemed to be Universities and Private Universities shall admit M.Phil./Ph.D. students through an Entrance Test conducted at the level of Individual University/Institution Deemed to be a University/Private University. The University/Institution Deemed to be a University may decide separate terms and conditions for Ph.D. Entrance Test for those students who qualify JRF/UGC-NET/SLET/M.Phil with course work. The total number of vacancies will be equally divided into candidates: 50% to those with JRF/UGC-NET/SLET/M.Phil., and the remaining 50% to the candidates who have passed entrance test conducted by the respective Higher Educational Institutions (HEIs). The serving senior Scientists (Scientists-D and above) can directly register for Ph.D. under a recognized guide. And these scientists are exempted from the Ph.D. entrance test and Ph.D. course work. The admission for such senior scientists can be made on the priority basis.
- 5.2 Higher Educational Institutions (HEIs) referred to in sub-clause 1.2 above and Colleges under them which are allowed to conduct M.Phil. and / or Ph.D. programmes, shall:
  - 5.2.1 decide on an annual basis through their academic bodies a predetermined and manageable number of M.Phil. and/or Ph.D. scholars to be admitted depending on the number of available Research Supervisors and other academic and physical facilities available, keeping in mind the norms regarding the scholar- teacher ratio (as indicated in Para6.5), laboratory, library and such other facilities;
  - 5.2.2 notify well in advance in the institutional website and through advertisement in at least two (2) national newspapers, of which at least one (1) shall be in the regional language, the number of seats for admission, subject/discipline-wise distribution of available seats, criteria for admission, procedure for admission, examination centre(s) where entrance test(s) shall be conducted and all other relevant information for the benefit of the candidates;
  - 5.2.3 adhere to the National / State-level reservation policy, as applicable.
- 5.3 The admission shall be based on the criteria notified by the Institution, keeping in view the guidelines / norms in this regard issued by the UGC and other statutory bodies concerned, and taking into account the reservation policy of the Central/State Government from time to time.
- 5.4 HEIs as mentioned in Clause 1.2 shall admit candidates by a two stage process through:

50/15  
NET Entrance

An Entrance Test shall be qualifying with qualifying marks as 50%.  
 The syllabus of the Entrance Test shall consist of 50% of research methodology and 50% shall be subject specific. The Entrance Test shall be conducted at the Centre(s) notified in advance (changes of Centers, if any, also to be notified well in advance) at the level of the individual HEI as mentioned in clause 1.2; and

- 5.4 An interview/viva-voce to be organized by the HEI as mentioned in clause 1.2 when the candidates are required to discuss their research interest/area through a presentation before a duly constituted Doctoral Committee.
- 5.5 The interview/viva voce shall also consider the following aspects, viz. whether:
- 5.5.1 the candidate possesses the competence for the proposed research;
  - 5.5.2 the research work can be suitably undertaken at the Institution/College;
  - 5.5.3 the proposed area of research can contribute to new/additional knowledge.
- 5.6 The University shall maintain the list of all the M.Phil. / Ph.D. registered students on its website on year-wise basis. The list shall include the name of the registered candidate, topic of his/her research, name of his/her supervisor/co-supervisor, date of enrolment/registration.
6. Allocation of Research Supervisor: Eligibility criteria to be a Research Supervisor, Co-Supervisor, Number of M.Phil./Ph.D. scholars permissible per Supervisor, etc.
- 6.1 Professor/ Associate Professors in the Post-Graduate departments of the University/Institution Deemed to be a University/College, who have Doctoral degree in the concerned subject/related subject shall be deemed to be the recognized guides in their subjects. Assistant Professor in the Post-Graduate departments of the university/institution deemed to be a university/college with a Ph.D. degree and at least one year of independent research experience after Ph.D. degree as evidenced by publications in refereed/reputed journals are eligible to be recognized as guides in their subjects.
- Teachers/ Scientists/ Professionals working in recognized institutions and teachers of constituent/ affiliated colleges, recognized as Research Centers by the University, who have doctoral degree in the concerned/ related discipline and at least one year of independent research experience after the Ph.D. degree as evidenced by publications in refereed/ reputed journals, and also teaching Post Graduate (PG) programmes in the colleges are eligible to be recognized as guides.
- Provided that in areas/disciplines where there is no or only a limited number of refereed journals, the Institution may relax the above condition for recognition of a person as Research Supervisor with reasons recorded in writing.
- 6.2 Co-Supervisor can be allowed in inter-disciplinary areas from other departments of the same institute or from other related institutions with the approval of the Doctoral Committee.
- 6.3 The allocation of Research Supervisor for a selected research scholar shall be decided by the Department concerned depending on the number of scholars per Research Supervisor, the available specialization among the Supervisors and research interests of the scholars as indicated by them at the time of interview/viva voce.
- 6.4 In case of topics which are of inter-disciplinary nature where the Department concerned feels that the expertise in the Department has to be supplemented from outside, the Department may appoint a Research Supervisor from the Department.

itself, who shall be known as the Research Supervisor, and a Co-Supervisor from outside the Department/ Faculty/College/Institution on such terms and conditions as may be specified and agreed upon by the consenting Institutions/Colleges.

6.5 A Research Supervisor/Co-supervisor, at any given point of time, cannot guide more than three (3) M.Phil. and Eight (8) Ph.D. scholars and two (2) foreign national candidates.

6.6 In case of relocation of an M.Phil./Ph.D. woman scholar due to marriage or otherwise, the research data shall be allowed to be transferred to the University to which the scholar intends to relocate provided all the other conditions in these regulations are followed in letter and spirit and the research work does not pertain to the project secured by the parent institution/ supervisor from any funding agency. The scholar will however give due credit to the parent guide and the institution for the part of research already done.

7. Course Work: Credit Requirements, number, duration, syllabus, minimum standards for completion, etc.

7.1 The credit assigned to the M.Phil. or Ph.D. course work shall be a minimum of 08 credits and a maximum of 16 credits.

7.2 The course work shall be treated as prerequisite for M.Phil./Ph.D. preparation. A minimum of four credits shall be assigned to one or more courses on Research Methodology which could cover areas such as quantitative methods, computer applications, research ethics and review of published research in the relevant field, training, field work, etc. Other courses shall be advanced level courses preparing the students for M.Phil./Ph.D. degree.

7.3 All courses prescribed for M.Phil. and Ph.D. course work shall be in conformity with the credit hour instructional requirement and shall specify content, instructional and assessment methods. They shall be duly approved by the authorized academic bodies.

7.4 The Department where the scholar pursues his/her research shall prescribe the course(s) to him/her based on the recommendations of the Doctoral Committee, as stipulated under sub-Clause 8.1 below, of the research scholar.

7.5 All candidates admitted to the M.Phil. and Ph.D. programmes shall be required to complete the course work prescribed by the Department during the initial one or two semesters.

7.6 Candidates already holding M. Phil. degree and admitted to the Ph.D. programme, or those who have already completed the course work in M.Phil. and also senior Scientists (Scientists/D and above) have been permitted to proceed to the Ph.D. may be exempted by the Department from the Ph.D course work. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. course work prescribed by the Department.

7.7 Grades in the course work, including research methodology courses shall be finalized after a combined assessment by the Research Advisory Committee and the Department and the final grades shall be communicated to the Institution/College.

7.8 A M.Phil./Ph.D. scholar has to obtain a minimum of 55% of marks or its

equivalent grade in the UGC 7-point scale (or an equivalent grade/CGPA in a point scale wherever grading system is followed) in the course work in order to be eligible to continue in the programme and submit the dissertation/thesis.

8. **Doctoral Committee and its functions:**

- 8.1 There shall be a Doctoral Committee as defined in the Statutes/Ordinances of the Institution concerned, for each M.Phil. and Ph.D. scholar. The Research Supervisor of the scholar shall be the Convener of this Committee. The composition of the Doctoral Committee shall be as follows:
- a) Chairperson of Board of Studies in the concerned subject - Chairperson
  - b) Chairperson, Department of Studies of the respective - Member  
Department/Head of the recognized Institution/Principal of the College or his/her nominee
  - c) The Senior most faculty member of the Department other - Member  
than the Chairperson of the Department of Studies. If there is no PG Department of Studies in the subject, a faculty member of the related department nominated by the Registrar (Evaluation)
  - d) A faculty member from the concerned area of specialization - Member  
nominated by the Vice-Chancellor
  - e) One outside expert during pre-thesis submission colloquium - Member  
only
  - f) Concerned research supervisor (Guide) \* - Member

\* Where the Guide is also the Chairperson of Board of Studies/Department of Studies/ Senior faculty, one more senior faculty member shall be nominated by the Vice-Chancellor

The committee shall meet as and when needed. The quorum for the meeting shall be three.

This Committee shall have the following responsibilities:

- 8.1.1 To review the research proposal and finalize the topic of research;
  - 8.1.2 To guide the research scholar to develop the study design and methodology of research and identify the course(s) that he/she may have to do.
  - 8.1.3 To annually review and assist in the progress of the research work of the research scholar.
  - 8.1.4 Undertake any function, exercise any powers entrusted in this statute or any work assigned to it.
- 8.2 A research scholar shall appear before the Doctoral Committee once in a year to make a presentation of the progress of his/her work for evaluation and further guidance. The six monthly progress reports shall be submitted by the Research Scholar to the Institution/College.



8.3 In case the progress of the research scholar is unsatisfactory, the Doctoral Committee shall record the reasons for the same and suggest corrective measures. If the research scholar fails to implement these corrective measures, the Doctoral Committee may recommend to the Institution /College with specific reasons for cancellation of the registration of the research scholar.

9. Evaluation and Assessment Methods, minimum standards/credits for award of the degree, etc.:

9.1 The overall minimum credit requirement, including credit for the course work, for the award of M.Phil. degree shall not be less than 24 credits.

9.2 Upon satisfactory completion of course work, and obtaining the marks/grade prescribed in sub-clauses 7.8 above, as the case may be, the M.Phil./Ph.D. scholars shall be required to undertake research work and produce a draft dissertation/thesis within a reasonable time, as stipulated by the Institution concerned based on these Regulations.

9.3 Prior to the submission of the dissertation/thesis, the scholar shall make a presentation in the Department before the Doctoral Committee of the Institution concerned which shall also be open to all faculty members and other research scholars. The feedback and comments obtained from them may be suitably incorporated into the draft dissertation/thesis in consultation with the Doctoral Committee.

9.4 M.Phil. scholars shall present at least two(2) research paper in a conference/seminar and Ph.D. scholars must publish at least two(2) research paper in refereed journal and make two paper presentations in conferences/seminars before the submission of the dissertation/thesis for adjudication, and produce evidence for the same in the form of presentation certificates and/or reprints.

9.5 The Academic Council (or its equivalent body) of the Institution shall evolve a mechanism using well developed software and gadgets to detect plagiarism and other forms of academic dishonesty. While submitting for evaluation, the dissertation/thesis shall have an undertaking from the research scholar and a certificate from the Research Supervisor attesting to the originality of the work, vouching that there is no plagiarism and that the work has not been submitted for the award of any other degree /diploma of the same Institution where the work was carried out, or to any other Institution.

9.6 The M.Phil. dissertation submitted by a research scholar shall be evaluated by his/her Research Supervisor and at least one external examiner who is not in the employment of the Institution/College. The viva-voce examination, based among other things, on the critiques given in the evaluation report, shall be conducted by both of them together, and shall be open to be attended by Members of the Research Advisory Committee, all faculty members of the Department, other research scholars and other interested experts/researchers. The Panel of Examiners has to be submitted to the University by the concerned Board of Studies.

9.7 The Ph.D. thesis submitted by a research scholar shall be evaluated by his/her Research Supervisor and at least two external examiners (selected by the Vice-Chancellor), who are not in employment of the Institution/College, of whom one examiner shall be from outside the country or outside the State. The viva-voce examination, based among other things, on the critiques given in the evaluation

report, shall be conducted by the Research Supervisor and at least one of the two external examiners, and shall be open to be attended by Members of the Doctoral Committee, all faculty members of the Department, other research scholars and other interested experts/researchers.

- 9.8 The open *viva-voce* of the research scholar to defend the dissertation/thesis shall be conducted only if the evaluation report(s) of the external examiner(s) on the dissertation/thesis is/are satisfactory. If the evaluation report of the external examiner in case of M.Phil. dissertation, or one of the evaluation reports of the external examiner in case of Ph.D. thesis, is unsatisfactory and does not recommend *viva-voce*, the Institution shall send the dissertation/ thesis to another external examiner out of the approved panel of examiners and the *viva-voce* examination shall be held only if the report of the latest examiner is satisfactory. If the report of the latest examiner is also unsatisfactory, the dissertation/ thesis shall be rejected and the research scholar shall be declared ineligible for the award of the degree.
- 9.9 The Institutions shall develop appropriate methods so as to complete the entire process of evaluation of M.Phil. dissertation/ Ph.D. thesis within a period of six months from the date of submission of the dissertation/thesis.
- 9.10 M.Phil./Ph.D. thesis shall be submitted to the institution both in hard and soft copies. The institution can adopt the appropriate methods of sending the hard/soft copies of the thesis depending upon the examiner's preference.
10. Academic, administrative and infrastructure requirement to be fulfilled by Colleges for getting recognition for offering M.Phil./Ph.D. programmes:

- 10.1 Colleges may be considered eligible to offer M.Phil./Ph.D. programmes only if they satisfy the availability of eligible Research Supervisors, required infrastructure and supporting administrative and research promotion facilities as per these Regulations.

Post-graduate Departments of Colleges, Research laboratories of Government of India/State Government/ recognized Research centers with at least two Ph.D. qualified teachers/scientists/other academic staff in the Department concerned along with required infrastructure, supporting administrative and research promotion facilities as per these Regulations, stipulated under sub-clause 10.3, shall be considered eligible to offer M.Phil./Ph.D. programmes. Colleges should additionally have the necessary recognition by the Institution under which they operate to offer M.Phil./Ph.D. programme.

- 10.2 Colleges/ recognized Research Centers with adequate facilities for research as mentioned below shall offer M.Phil./Ph. D. programmes:

10.2.1 In case of science and technology disciplines, exclusive research laboratories with sophisticated equipment as specified by the Institution concerned with provision for adequate space per research scholar along with computer facilities and essential software, and uninterrupted power and water supply;

10.2.2 Earmarked library resources including latest books, Indian and International journals, e- journals, extended working hours for all disciplines, adequate space for research scholars in the Department/ library for reading, writing

and storing study and research materials;

10.2.3 Colleges/recognized Research Centers may also access the required facilities of the neighboring Institutions/Colleges, or of those Institutions/Colleges/R&D laboratories/Organizations which have the required facilities.

**11. Treatment of Ph.D. / M.Phil. through Distance Mode/Part-time:**


- 11.1 Notwithstanding anything contained in these Regulations or any other Rule or Regulation, for the time being in force, no University; Institution, Deemed to be a University and College shall conduct M.Phil. and Ph.D. Programmes through distance education mode.
- 11.2 Part-time Ph.D. will be allowed provided all the conditions mentioned in the extant Ph.D. Regulations are met.

**12. Award of M.Phil./Ph.D. degrees prior to Notification of these Regulations, or degrees awarded by foreign Universities:**

- 12.1 Award of degrees to candidates registered for the M.Phil./Ph.D. programme on or after July 11, 2009 till the date of Notification of these Regulations shall be governed by the provisions of the UGC (Minimum Standards and procedure for Awards of M.Phil./Ph.D. Degree) Regulation, 2009.
- 12.2 If the M.Phil./Ph.D. degree is awarded by a Foreign University, the Indian Institution considering such a degree shall refer the issue to a Standing Committee/Equivalence committee constituted by the concerned institution for the purpose of determining the equivalence of the degree awarded by the foreign University.

**13. Depository with INFLIBNET:**

- 13.1 Following the successful completion of the evaluation process and before the announcement of the award of the M.Phil./Ph.D. degree(s), the Institution concerned shall submit an electronic copy of the M.Phil. dissertation /Ph. D. thesis to the INFLIBNET, for hosting the same so as to make it accessible to all Institutions/Colleges.
- 13.2 Prior to the actual award of the degree, the degree-awarding Institution shall issue a provisional Certificate to the effect by the Registrar (Evaluation) stating that the Degree has been awarded in accordance with the provisions of these UGC Regulations, 2016.



ವಿಷಯ: Anomalies in the age of Superannuation of Directors of Physical Education and Librarians Universities in Karnataka State for Corrective Measures.

**PREAMBLE:**

During the meeting of General Council held on 20.08.2016, Prof. Coutinho, Member of University Review Commission has raised the issue regarding "The Anomalies in the age of Superannuation of Directors of Physical Education and Librarians in the University in Karnataka". He has expressed that the age of superannuation of Directors of Physical education and Librarians in the state Universities is being different which has to be corrected/ modified by the Government of Karnataka in the way of Statutes/ Government Orders.

Prof. Coutinho, has submitted copies of the UGC Notification/ Regulations/ Universities Statutes/ State Government Orders/ Notifications along with a copy of the judgement of the High Court Writ Appeal No.576 of 2015 and various Universities orders issued while superannuating from the post of Directors of Physical Education and Librarians.

On verification of Government Orders, UGC Orders and letters it is stated that Librarians working in the Universities should be treated on par with the Teachers and also to be treated as Academic and (Non- Vocational staff, vide UGC letter dated:08.06.1998 and GO dated 27.06.1998)

Some of the Directors of Physical Education and Librarians have been retired at the age of 60 and 62 in certain Universities. It is appeared that there is disparity in adopting the provisions of UGC Regulations/ State Government Orders.

Some of the examples in certain Universities have quoted are as below:

As gone through the UGC Regulations/State Government Orders (ED.37 UNE 2009, dated: 24.12.2009 and GO No. AHD 64, AUM 2009, dated:24.03.2010) it is mentioned that Superannuation age of Teachers/Librarians of Agricultural universities drawing UGC/ICAR scales shall be 62 with effect from 28.10.2009 as per the GO dated 28.10.2009. The age of Superannuation of the Teachers and Librarians of Horticultural Universities shall be enhanced to 62 years from prospective effect. As per the Government Orders the State Universities will have to frame draft Statutes and to submit to the Government of Karnataka with the approval of Syndicate for the assent of the Chancellor. Some of the Universities have framed Draft Statutes and submitted to the Government for approval.

The Government of Karnataka in its Order No. ED 254 UNE 2014, dated: 28.09.2015 has clarified that the persons working in the Library and Physical Education should not be treated as Teachers, it is not justifiable and mandatory to revise the Superannuation age from 60 to 62 years in the Universities and Colleges in the State.

Anomalies in the age of Superannuation of Directors of Physical Education and Librarians prevailed in the State Universities is listed above.

Hence, the matter is placed before the General Council meeting for its discussion and decision.

After detailed discussion with reference to the anomalies in the age of Superannuation of Personnel of Dept. of Physical Education and Library Science was discussed in the meeting in terms of the Govt. Orders/UGC etc., The Universities have taken different decisions on this issue. Hence, the above Non-teaching staff working in the departments should be treated as Non-Vocational Teachers and they shall be Superannuated at the age of 60 instead of 62 in the Universities and the Colleges in the State as per G.O No. ED 254 UNE 2014, dated 28.09.2015.
