STATUTE OF KARNATAKA SAMSKRIT UNIVERSITY AFFILIATION TO COLLEGES

(GRANT OF AFFILIATION OF COLLEGES AND INSTITUTIONS AND WITHDRAWAL OF SUCH AFFILIATION)

(Framed under Section 41 of Karnataka Samskrit University Act. 2009)

1. Title and Commencement:

- i) This Statute shall be called 'Statute of the Karnataka Samskrit University's affiliation to colleges (Grant of Affiliation to colleges and institutions and withdrawal of such affiliation)'.
- ii) This Statute shall come into force from the date of assent of the Chancellor.

2. Eligibility for Permanent Affiliation:

A College (or an Institution which conduct research or specified studies leading to degrees, including Evening College) shall be eligible for permanent Affiliation in any Course/Subject, only when it has enjoyed temporary affiliation for a continuous period of 5 years in that course/subject and has fulfilled all the conditions of affiliation and attained the academic and administrative standards prescribed by the University from time to time.

Note: Initially a new college shall be given temporary affiliation for a maximum term of three years, extendable for five years.

3. Eligibility Criteria for Temporary Affiliation:

The proposed college seeking affiliation, at the time of inspection by the University, shall satisfy the following requirements, or the requirements in respect of any of them prescribed by the Statutory/Regulatory body concerned, whichever is higher:

- a) Administrative, academic and other buildings with sufficient accommodation to meet the immediate academic and other space requirements as specified by the University concerned for each of the higher education course/programme with adequate scope for future expansion in conformity with those prescribed by the UGC/Statutory/Regulatory body concerned, taking care that all buildings constructed in the college are disabled friendly;
- b) Academic building sufficient to accommodate the faculties, lecture/seminar rooms, library and language laboratories with a minimum of 15 sq.ft. per student in lecture/ seminar rooms/library and 20 sq.ft. per student in each of the laboratories;
- number of qualified teaching and non-teaching staff as per University/UGC/ Regulatory norms;
- d) adequate civic facilities for essentials like water, electricity, ventilation, toilets, sewerage, etc. in conformity with the norms laid down by the Central/State PWD;
- e) a library with at least 1000 books with 100 books in different titles on each subject, whichever is more, of the proposed programmes to include both text books and

reference books, besides two journals per subject, along with a book bank facility for students belonging to the Scheduled Castes, Scheduled Tribes and such other sections as may be specified by the UGC from time to time;

- f) Necessary language laboratory equipments as prescribed by the University/Statutory/ Regulatory body concerned, for each of the higher education programmes;
- g) a multi-purpose complex/ an auditorium and facilities for sports, canteen, health care, separate common rooms and separate hostels for boys and girls as per the local requirements as decided by the University;
- h) appropriate furniture for lecture/seminar rooms, laboratories, library, faculty rooms, rooms for administrative staff including the Principal, multi-purpose complex / auditorium, common rooms and hostel rooms, and for other facilities.

4. Who should apply:

In the case of a Government college, the Officer authorised in this behalf by the Government and in the case of other colleges, the management of the college or the institutions, which shall be a body registered under the Society's Registration Act or any other legal body, shall apply to the Registrar, Karnataka Samskrit University seeking affiliation and such application containing all the required particulars along with the prescribed fee shall reach the Registrar not later than the date notified by the University during the preceding year, latest by December 31.

5. Particulars which the application should contain:

Every such application shall contain the following particulars:

- a) Name of the college and year of establishment;
- b) Constitution and Personnel of the Governing body;
- c) Courses and subjects in respect of which affiliation is sought;
- d) Accommodation, equipment, furniture, the strength of the college or institute, the number of students classwise and combination for whom provisions have been made (the information relating to accommodation must be accompanied by blue prints);
- e) The detailed statement of assets and liabilities of the college duly certified by the Chartered Accountant:
- f) Previous application, if any for permanent affiliation in the same subject to this University and their disposal;
- g) Hostel accommodation for students;
- h) The total area of land under possession and the extent of playgrounds;
- i) Sanitary arrangements, Canteen and other amenities to students:
- A statement of expenditure incurred in the last five years towards Library, Equipment and Furniture except salary;
- k) Number of qualified teaching Faculty in each subject as per UGC (with detailed breakup).

Note: The provision contained in clause (e) will not apply to an application made by a Government college.

6. Fee:

Affiliation fee for permanent affiliation is Rs. 25,000/- and for Provisional Affiliation is Rs. 10,000/- which shall be paid with the application, for subsequent years the college shall pay Rs. 5,000/- during the month of October every year. In the case of SC/ST colleges, Government rule may be followed.

Affiliation fee for Professional courses shall be Rs. 35,000/- in respect of Education etc. shall be paid along with the application; for subsequent years Rs. 5,000/- shall be paid during the month of October every year. For re-inspection of colleges Rs. 10,000/- shall be paid. It can be revised by time to time.

7. Steps to be taken on receipt of such application:

On receipt of application, the Syndicate shall-

- a) direct a Local Enquiry to be made by competent persons authorised by the Syndicate in this behalf in respect of the matters referred to under the statement and such other matters as may be deemed necessary and relevant including particularly in the case of composite colleges whether the teaching facilities available are adequate for the Colleges;
- b) make such further enquiry as may appear to it to be necessary;
- c) thereafter, the matter to the Academic Council for its opinion on the application.
- d) Last date of application every year shall be December 31.

8. Local Inquiry Committee:

The Local Inquiry Committee shall consist-

- 1. One member nominated by Vice-Chancellor
- 2. One each member from Academic Council and Syndicate
- 3. One member from Faculty
- 4. Director, CDC shall be the Secretary of the LIC.

Vice-Chancellor shall nominate the Chairperson of the Committee one among the members.

The Registrar shall submit its report to the Academic Council and Syndicate. The proceedings shall be communicated to the concerned and to the Government.

9. Conditions which will have to be fulfilled before grant of Permanent Affiliation to any college or institution.

The College or Institution shall satisfy the following general conditions before permanent affiliation could be granted to it-

- i) The college building shall have the following facilities in addition to the class rooms
 - a) Permanent building (Owned or Leased for long period), with sufficient accommodation which can meet the academic requirements.
 - b) A common room for teachers with sanitary facilities.
 - c) A separate room for girl students if it is a co-educational institution with sanitary facilities.

- d) A library hall with books shelves and reading hall to accommodate.
- e) Office room for Principal, Office room for Administrative staff and records and computers & Network facilities.

The College shall have an-

- f) Auditorium large enough to accommodate all students at a time.
- g) The college shall have a play field with a running track of 200 meter and provide facilities for games and sports and have sports material room provided that this may be relaxed to some extent in the case of City Colleges and completely waived in the case of evening colleges.
- h) The college should have made adequate facilities to the members of the teaching and non-teaching staff for improvement of their academic qualifications.
- i) The College should have ensured that the academic and welfare activities of the Backward Class, Scheduled Caste and Scheduled Tribes students have been properly looked into and special attention has been paid to look into their problems.
- j) The College shall conduct the Co-curricular, extra-curricular and social activities.
- k) The college should have made sufficient arrangement to have the students examined every year by a competent Medical officer and where the Medical Officer recommends that a student needs any particular treatment, the same shall be communicated to the parent/guardian.
- 1) The college rules fixing fee to be paid by the students shall be in conformity with those prescribed by the University or Government.

10. Administrative standards (including financial requirements) required to be attained for grant of Permanent affiliation.

- 1) There should be a Governing Council properly constituted in the case of Non-Government colleges and an Advisory Committee in the case of Government Colleges. The powers and functions of the Committee should be well defined to make the Committee effective. The total number of members of the Governing Council will ordinarily be not less than seven and more than eleven. At least one member of the Governing Council shall be a teacher representative, other than the Principal.
- The Executive Committee members of the Educational Society which runs the college, and for which temporary affiliation has been granted, should not belong to one Community/Caste or to one family and for the Educational Institute being managed by the SC/STs there shall at least be fifty percent of its members of the Management belonging to SC/STs.
- 3) All records or registers as are required to be maintained as required under University regulations/Government Orders and they shall be up-to-date. They shall be made available at any time when required for inspection.
- 4) The recruitment of staff shall be as per UGC regulations as laid down from time to time.

- 5) There shall be Board of Appointment approved by the University consisting of Faculty experts to select teachers.
- 6) The members of the teaching and non-teaching staff should be regularly and fully paid as per prescribed rules.
- 7) The Management shall arrange to have its accounts audited by the end of each year by a Chartered Accountant. The annual accounts and the audited reports shall be made available to the University and to the Government for inspection, wherever applicable. Annual General Body meeting shall be convened regularly.
- 8) The details of grants received from the UGC for various purposes and its utilization should be made available.
- 9) The details of grants received from the State Government for various purposes and its details should be available.
- 10) Details of donations received from Philanthropists, its purpose and utilization details etc. should be scrupulously recorded, audited and those records be made available for inspection.
- 11) (a) A Register of admission and withdrawals
 - (b) A Register of attendance
 - (c) A Register of fees paid showing date of payment
 - (d) A Counterfoil fee receipt book
 - (e) Account Books showing financial transactions of the College of separate from those of the Management. The accounts shall show transactions in full.
 - (f) A Register of Scholarships and Concessions of all kinds whether of tuition, boarding and lodging.
 - (g) A Register or other records of addresses of students.
 - (h)A Register of Marks obtained by each student at the college terminal examinations.
 - (i) A Counterfoil Book of Transfer Certificates
 - (j) A Service Register as prescribed from time to time for each member of the staff.
 - (k) A Register of members of the Staff showing qualifications, previous experience, salaries, number of hours of work and classes and the subjects taught.


11. Academic standard required to be attained for grant of permanent affiliation.

For the purpose of granting permanent affiliation the college or institution should have fulfilled the following academic requirements.

- 1) The number of the staff shall be as per University requirements as fixed from time to time and at least 75% required staff appointed should be permanent including the physical Instructor and Librarian.
- 2) Qualification of the teaching staff shall be as per UGC/Govt. guidelines.

- 4) The College Library shall have some important minimum number of books in each subject as may be prescribed by the Faculties, Boards of Studies, etc., including the reference books, text books and some standard journals for the students.
- 6) The College shall have a parent - teachers association.
- 7) Adequate representation on the staff of teaching and non-teaching must have been given to the SC/STs and other backward castes in accordance with the reservations for SC/STs as prescribed by State Government. Register should be maintained wherein seniority of teachers along with category from which they were recruited is recorded.
- 8) It shall be open to a college, after obtaining the previous approval of the University, to suspend in any subject or subjects or courses of study in which the college or institute is permanently affiliated. The classes in the subject or subjects suspended shall not be re-started without obtaining the previous sanction of the Syndicate. and if the work is not resumed at the end of a period of three years, the affiliation previously granted shall be regarded as having lapsed. Provided that wherein any year a college being prepared to make the usual arrangements to give instructions in subjects in which it has been affiliated, does not for want of students offer instruction in one or more of these subjects and it reports to the University within a fortnight after the last date prescribed for the admission, it shall not be deemed that the College or Institute, has suspended instruction in the subject or subjects concerned.
- 9) In case of closure of a Dept./College, the University shall make an alternative arrangement for the students for their studies. In case of the colleges under Grantin-aid, the University has got authority to transfer the staff (Teaching/Non-Teaching) if any Dept./College for any reason gets closed.
- Every College which has been granted permanent affiliation, shall forthwith report 10) to the University all changes effected in the management, teaching staff and all other changes affecting the terms and conditions of affiliation.
- 11) Periodical Inspection:

The University shall arrange to have periodical inspection of every permanently affiliated college once in three years.

12) Withdrawal of affiliation:

> If the college to which permanent affiliation has been granted has failed to comply with or failed to observe any of the conditions of its affiliation or has been conducted in a manner which is prejudicial to the interest of Education, the University may withdraw in whole or in part or modify the rights conferred on the college by affiliation, after following the procedure prescribed in section 56 of the KSU Act.
